# FACTSHEET GENDER BASED VIOLENCE WORKING GROUP

July 2019

The ongoing political, socio-economic and human rights events in Venezuela have led to the outflow of almost 4 million refugees and migrants, the biggest population movement in the history of Latin America and the Caribbean. The Gender-Based Violence (GBV) working group of the Regional Coordination Platform supports national stakeholders to prevent and respond to GBV using a multi-sectoral, survivor-centered approach based on international humanitarian principles. In line with the 2019 Regional Response Plan for Refugees and Migrants from Venezuela (RMRP), the GBV working group prioritizes prevention, mitigation and response to GBV, with special emphasis on addressing sexual violence and trafficking in persons for the purpose of sexual exploitation.

Along the migratory route, refugees and migrants from Venezuela, especially women and girls, face high risks of exploitation, human trafficking, sexual violence and other forms of GBV.

## MAIN GBV CHALLENGES

#### **GBV UNREPORTED**

Underreporting of GBV cases, largely due to fear (heightened for those travelling without official documents) and lack of information about rights and services

#### LACK OF QUALITY GBV DATA

Insufficient sex and age disaggregated GBV data for refugees, migrants and local populations to inform needed policy and service protocols

#### **INSUFFICIENT GBV SERVICES AND FACILITIES**

GBV specialist capacity is lacking. Services and facilities (health, psychosocial, legal/justice and safe/security) are currently insufficient and lack integration across sectors

#### LACK OF ADOLESCENT FRIENDLY SERVICES

Limited age-appropriate training, materials and services for adolescent girls and boys

## **RMRP BUDGET**

Approximately 11% of the RMRP budget is dedicated to GBV prevention and response.



## **GBV PRIORITY ACTIONS**

Ensure availability and accessibility of age and culturallyappropriate, quality services for GBV survivors, including through development of GBV referral pathways.

Provide clear and accessible information on where to access lifesaving services to women and girls along transit.

Strengthen cross-border coordination to ensure coherent and systematic GBV prevention and response measures.

Support the creation of safe and effective livelihood programs that help to prevent and mitigate GBV in humanitarian settings.

Strengthen capacities of government institutions to address GBV.

Strengthen collaboration with civil society and local organizations with the relevant expertise.
